



**Regulation No. 151/2020
of the Rector of the University of Opole
of November 13, 2020**

**on the rates of benefits for doctoral students at the University of
Opole in the academic year 2020/2021**

Pursuant to **Article 95(1)(1)** of the Act of 20 July 2018 - *Law on Higher Education and Science* (Journal of Laws of 2020, item 85 as amended), in connection with **Article 281(1) and (2)** of the Act of 3 July 2018 - *Rules implementing the Act - Law on Higher Education and Science* (Journal of Laws of 2018, item 1669 as amended), and **Section 9(1)(2) and (3)** in connection with **Section 19** of the *Rules on benefits for students and doctoral students at the University of Opole* (Appendix 1 to Regulation No. 104/2020 of the Rector of the University of Opole of 15 September 2020 on the Rules on benefits for students and doctoral students at the University of Opole), the Rector of the University of Opole orders the following:

§ 1

1. The rates of benefits for doctoral student in the academic year 2020/2021 shall be set as follows:

1) **maintenance grant:**

AVERAGE MONTHLY NET INCOME PER FAMILY MEMBER IN ZŁOTYS	RATE OF MAINTENANCE GRANT IN ZŁOTYS
up to 200	900.00 PLN
from 200.01 to 400.00.	850.00 PLN

2) **scholarship for the disabled:**

3) **Rector's scholarship for the best doctoral students**

II	1100 PLN
III	800 PLN
IV	500 PLN

§ 2

In particularly justified cases referred to in **Section 13(2)(1-4)** of the *Rules of benefits of students and doctoral students at the University of Opole*, a student may receive a maintenance grant of an increased amount (up to PLN 300) if his/her per capita family net income does not exceed **PLN 1051.70**.

§ 3

The maximum amount of the aid is **PLN 800**.

§ 4

The rates of benefits for doctoral students have been agreed with the Doctoral Students' Union of the UO.

§ 5

The regulation shall enter into force on the date of signature with effect of 01 October 2020.
