MEMORANDUM OF UNDERSTANDING

between

UNIVERSITY OF MARIBOR
Faculty of Law

and

UNIVERSITY OF OPOLE
Faculty of Law and Administration

University of Maribor Faculty of Law (Maribor, Slovenia) and **University of Opole Faculty of Law and Administration** (Opole, Poland), hereafter referred to as the Parties, in order to promote their international academic cooperation and exchange enter into the following Memorandum of Understanding (MOU).

Article 1

Both parties would agree on mutual activities that aim to develop the scientific and cultural projects for the benefits of students and academic staff in both institutions.

Article 2

Both parties would agree on certain fields of cooperation such as:

- Exchanging academic and research information;
- Organizing conferences for academic staff and students;
- Developing research projects for academic units.

The Parties agree to coordinate and harmonize the above listed activities especially in the following fields:

- Law.

Article 3

Both parties would exchange visits by the Universities academic staff and students. However, the number of visitors, their specialties and the purpose of their visits should be determined in advance.

Article 4

Both parties would exchange visitors from administrative departments for training purposes. However, the number of visitors, their specialties and the purpose of their visits should be determined in advance by correspondences.

Article 5

Both parties exchange student delegations for scientific and cultural purposes. The student delegations should be accompanied and headed by a teaching staff member as a supervisor, and the duration of the visits shall be agreed upon in advance by correspondence between both parties.

Article 6

Financial and administrative matters would be agreed upon by direct contact between both Parties in advance. Present MOU is not financially and legally binding for either Parties.

Article 7

In the case of adding a new item or amending any texts of the presents MOU, all amendments must be agreed upon by both Parties in advance.

Article 8

This MOU gets effect upon the date of its signing and remain valid for a period of 5 years. It is renewable unless one of the Parties expresses its desire to withdraw before 6 months from the expiry date.

Article 9

In case of cancellation, both Parties agree on carrying on their activities approved earlier till the end. The agreement is signed in four copies.
